



**SHOAL CREEK LIVING HISTORY MUSEUM  
GENERAL RELEASE AND WAIVER OF LIABILITY  
FILMING CONTRACT**

The undersigned represents \_\_\_\_\_ (the "Participant"), will be filming at the Shoal Creek Living History Museum (the "Museum") on \_\_\_\_\_, for \_\_\_\_ hours.

In consideration of the Participant/Participants being permitted to participate in the filming, the undersigned, for himself or herself and any personal representatives and heirs, and for the Participant, hereby waives, releases and relinquishes the Museum and its directors, officers, agents, volunteers, and employees (collectively, the "Parties"), from any and all losses, expenses, claims, actions, judgments or damages (including all reasonable costs of defense and attorney's fees) (collectively, the "Claims"), arising from or related to the Participant's participation in the Filming. The undersigned, for himself or herself and any personal representatives and heirs, and for the Participant, hereby irrevocably covenants to refrain from, directly or indirectly, asserting any Claims, or commencing, instituting, or causing to be commenced, any proceeding of any kind against the Parties based upon any Claims.

Below are the fees listed with descriptions to follow. All fees must be paid at the time the reservation is made. Once the date is confirmed and all documents have been submitted and approved, an invoice via Square will be sent to the designated production member and must be paid upon receipt.

The participant/participants must provide a certificate of liability insurance in the amount of \$1,000,000 (one million) dollars with The City of Kansas City, MO and Shoal Creek Association named as additional insured. Credits are to include the City of Kansas City, MO Parks and Recreation Department, Shoal Creek Living History Museum, and Shoal Creek Association.

The facility fee is for the use of Shoal Creek Living History Museum to include the park grounds/buildings or both.

The association fee is for the use of trained volunteers to open buildings and gates that lead into the park, keep the areas, being used for filming, free of patrons that are not involved in the filming, approve for items to be moved or rearranged in any of the buildings whether interior or exterior.

The refundable security deposit will be refunded within two weeks of the filming date so long as Shoal Creek Living History Museum was left the way it was found. A walk through, in the areas to be used for filming, will be completed before and after filming with a designated person from the production company and a Shoal Creek Association board member. If any damage is found, post filming, to Shoal Creek Living History Museum artifacts, wall hangings, décor, furnishings, structures, or the park grounds and exceeds the security deposit, further action will be taken.

By signing this document, the undersigned acknowledges that he/she has read this document in its entirety and that he/she fully understands its terms. The undersigned further agrees that this document is intended to be as broad and inclusive as is permitted by the law of the state of Missouri and that if any portion thereof is held invalid the remainder shall continue in full legal force and effect.
